ORDER OF REVOCATION OF
UNRESTRICTED LICENSE AND FOR
ISSUANCE OF RESTRICTED LICENSE
AND EXAMINATION FEE

16 WHEREAS, Respondent, RYAN ADAM MULLINAX, has entered into a
17 Stipulation and Waiver in this matter, and whereby as part of said Stipulation and Waiver,
18 Respondent stipulated and agreed that the allegations contained in Accusation issued in this
19 matter constitute grounds for the revocation of Respondent's license and licensing rights to act as
20 a bail agent, and that there be issued to Respondent a restricted license to act in said capacity; and

22 WHEREAS Respondent in the Stipulation and Waiver expressly waives a hearing in
23 this matter; and GOOD CAUSE APPEARING;

25 IT IS HEREBY ORDERED that pursuant to said Stipulation and Waiver,
26 Respondent's license and licensing rights to act as a bail agent be, and the same hereby are,
27 REVOKED, and it is further ordered that there be issued to Respondent, upon Respondent's
28 compliance with all statutory and regulatory requirements, a restricted license to act in the

1 capacity of a bail agent, pursuant to the provisions of California Insurance Code Section 1742 and
2 1805, and subject to the conditions and restrictions contained in the Stipulation and Waiver.

3 IT IS FURTHER ORDERED that the aforesaid restricted license of Respondent
4 shall remain subject to said conditions and restrictions until such time as the Insurance
5 Commissioner shall by written order remove or modify them, and the restrictions shall apply to
6 said license and any renewal regardless of whether the same shall have actually been endorsed
7 thereon.

9 IT IS FURTHER ORDERED that Respondent shall pay an examination fee in the
10 amount of four hundred and seventy seven dollars (\$477) as enumerated in the Stipulation and
11 Waiver.
