ORDER OF REVOCATION OF LICENSE
AND ISSUANCE OF RESTRICTED
LICENSE

16 WHEREAS, Respondent, JOHN CHRISTOPHER SBICCA, has entered into a Special
17 Notice of Defense in this matter, and whereby as part of said Special Notice of Defense,
18 Respondent stipulated and agreed that grounds exist for the revocation of his license and licensing
19 rights as a Life Agent, and that there be issued to Respondent a Restricted License to act in that
capacity.

20 WHEREFORE, IT IS HEREBY ORDERED that pursuant to said Special Notice of
21 Defense, license and licensing rights to act as a Life Agent be, and the same hereby is,
22 REVOKED, and it is further ordered that there be issued to Respondent, upon Respondent's
23 compliance with all statutory and regulatory requirements, a Restricted License to Act in the
24 capacity of a Life Agent pursuant to the provisions of California Insurance Code Section 1742
and subject to the conditions and restrictions contained in the Special Notice of Defense.

25 IT IS FURTHER ORDERED that the aforesaid Restricted License of Respondent shall
26 remain subject to said conditions and restrictions until such time as said Insurance Commissioner
27 shall by written order remove or modify them, and they shall apply to said license and any
28 renewal regardless of whether the same shall have actually been endorsed thereon. It is further
ordered that after four (4) years from the date of execution of this Order, the Insurance

1 Commission, upon petition by the Respondent, shall remove the conditions and restrictions from
2 Respondent's license if there has not been a justified investigated complaint against Respondent,
3 and neither an investigation nor disciplinary action against Respondent is then pending.
